- Yosef Benjamini, attached to the Palestine Police Railway Detachment, was found dead in the Beilinson Hospital, Petah Tiqva, on Friday the Second June, 1939.
- 2. His death was due to internal hemorrhage resulting from shotwounds sustained while patrolling the Ras-el Ein Jaljulia Road near kilo 88 of Ras-el-Ein Qalqilya railway line.
- 3. The said Yosef Benyamini was killed by unknown person or persons.
